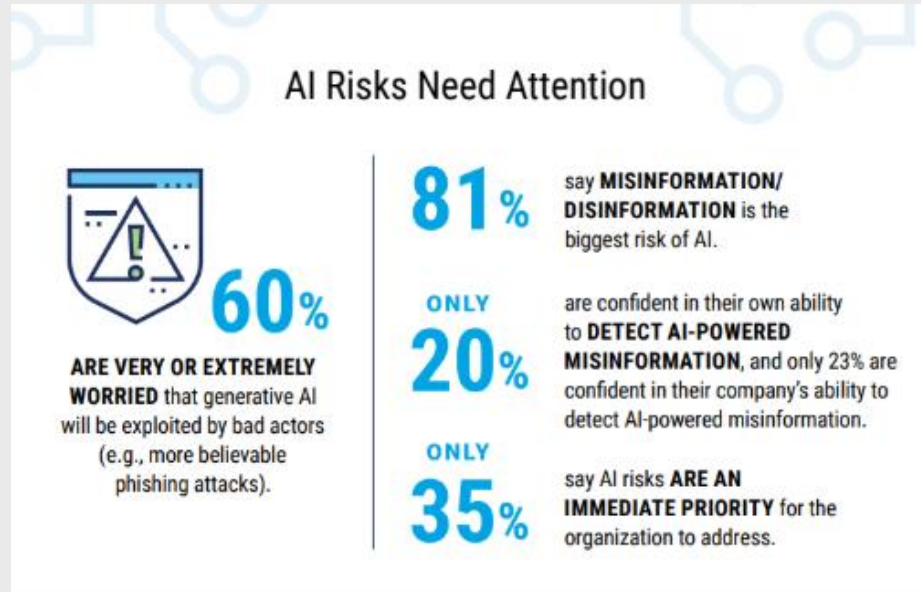

The Beta and Train-the-Trainer applications will be available on **June 2** (application link to come).

Eligible applicants will be selected on or before **June 16**.

Beta is available to CISM and CISSP holders; Train-the-Trainer is available to CISM accredited trainers.

**The cost is \$399 and includes exam and review manual.**

## Exam Preparation:

**June 16:** Selected participants will receive exam prep material.

- Volunteers should begin studying and preparing to sit for the AAISM Certification exam.

## Exam:

**July 7 – July 21:** Participants will be able to sit for the AAISM exam

- The exam will be self-scheduled through ISACA's exam administrator, PSI.
- The **exam must be completed by July 21**.
- During the beta, the AAISM exam will only be available through remote proctor.
- Note: The exam will only be available during this two-week period. If you are unable to sit for the exam during this time, please refrain from applying. You will not be eligible for a refund.*
