# 5-Day Training ToC - Internal Audit Engagement

#### **Overview**

It covers managing audit activities, planning and performing engagements, communicating results, and monitoring progress. The program blends theoretical knowledge with practical applications to prepare participants for real-world internal audit scenarios.

#### **Prerequisites**

- Basic understanding of internal controls and risk management concepts.
- Familiarity with governance, compliance, and audit principles.
- Prior experience in auditing, accounting, or finance is recommended but not mandatory.

### Day 1: Managing the Internal Audit Activity (20%)

#### Engagement Work Program Development

- Designing engagement procedures.
- Determining staffing and resource needs.

### Day 3: Performing the Engagement (40%)

### • Information Gathering Techniques

- o Interviews, walk-throughs, observations.
- o Checklists, risk-control questionnaires.
- o Statistical and non-statistical sampling methods.

#### Analysis and Evaluation

- Using audit tools (data mining, continuous monitoring).
- Evaluating evidence for sufficiency, relevance, and reliability.
- Analytical techniques: ratio estimation, variance analysis, benchmarking.

#### **Day 4: Communicating Results and Monitoring Progress (20%)**

#### • Engagement Results Communication

- Preparing workpapers and supporting documentation.
- Summarizing findings, risks, and control assessments.

#### • Engagement Supervision

 Work assignments, reviewing workpapers, evaluating team performance.

### Monitoring Progress

- Following up on identified risks.
- Role of Chief Audit Executive in residual risk assessment and communication.
